

1. Glenwood Bridge Initiative: Gary Segers, Bob Haye, and Gary Payne Met with ITD District 3 Commissioner, Julie DeLorenzo and ITD District 3 Director, Caleb Lakey. ITD District 3 is in SW Idaho. There was no existing study of the Glenwood Bridge. It was constructed in 1995. Data was provided by COMPASS. Thank you to Mark Wasdahl for requesting the data be taken.



Most bicyclists ride on the sidewalk. There is no true bike lane.

The idea Don Kostelec suggested to remove the turn lane for the length of the bridge is under consideration. There was another bridge that recently was reconfigured for this exact same reason.

The Glenwood Bridge connects the community to the Greenbelt and to their schools such as Capital High School.

Concrete from State to Myrtle Street




Small islands inserted for pedestrian/bikers to be to be safer while drivers turn right.

3. King County to Pay \$10M to Cyclist Paralized in Bollard Crash

Seattle, Washington had to pay \$10M to Cyclist who rode into a bollard in July, 2023. Gary Segers has requested that these bollards be removed or better marked.





AASHTO Guidelines:

- Use Pavement Warning Stripes
- Apply Retro-reflectorized markings on the bollard
- Odd number posts should be spaced at least 6 feet apart
- Only use when there is a documented history of unauthorized intrusion by motor vehicles
