- a) Moving FACTS website from Gary Payne's personal site and onto its own utilizing a company called Elementor, which provides both hosting and design tools for as low as \$2.99 per month.
- b) SO EXCITED TO REPORT...At its meeting on November 19, the Garden City Parks & Waterways Committee was thrilled to meet with Shawn McFadden and Ed Vetter who own the property at the intersection of 52<sup>nd</sup> Street and the Green Belt. Committee members learned that Ed & Shawn deal with many challenges arising from the current detour and fully support constructing a bridge to Plantation Island that would create a safe and pleasant Green Belt route. The over-all vision would be to use the \$2M grant from COMPASS as seed money to entice other players, both private and public into an effort to design/build the bridge. The goal would be to attract multiple entities to the project and ask each to contribute a little so that no one entity has to carry all of the burden. Project Member contributions could be in the form of time, expertise, materials, equipment, manpower; and, of course, cash. One such individual might be John Ferguson. Concrete Placing Company.
- c) Cataloging all connection points to Green Belt, including HOAs along the river. Ground floor, as an example, is the infrastructure welcomed in such segments as the Waterfront District.
